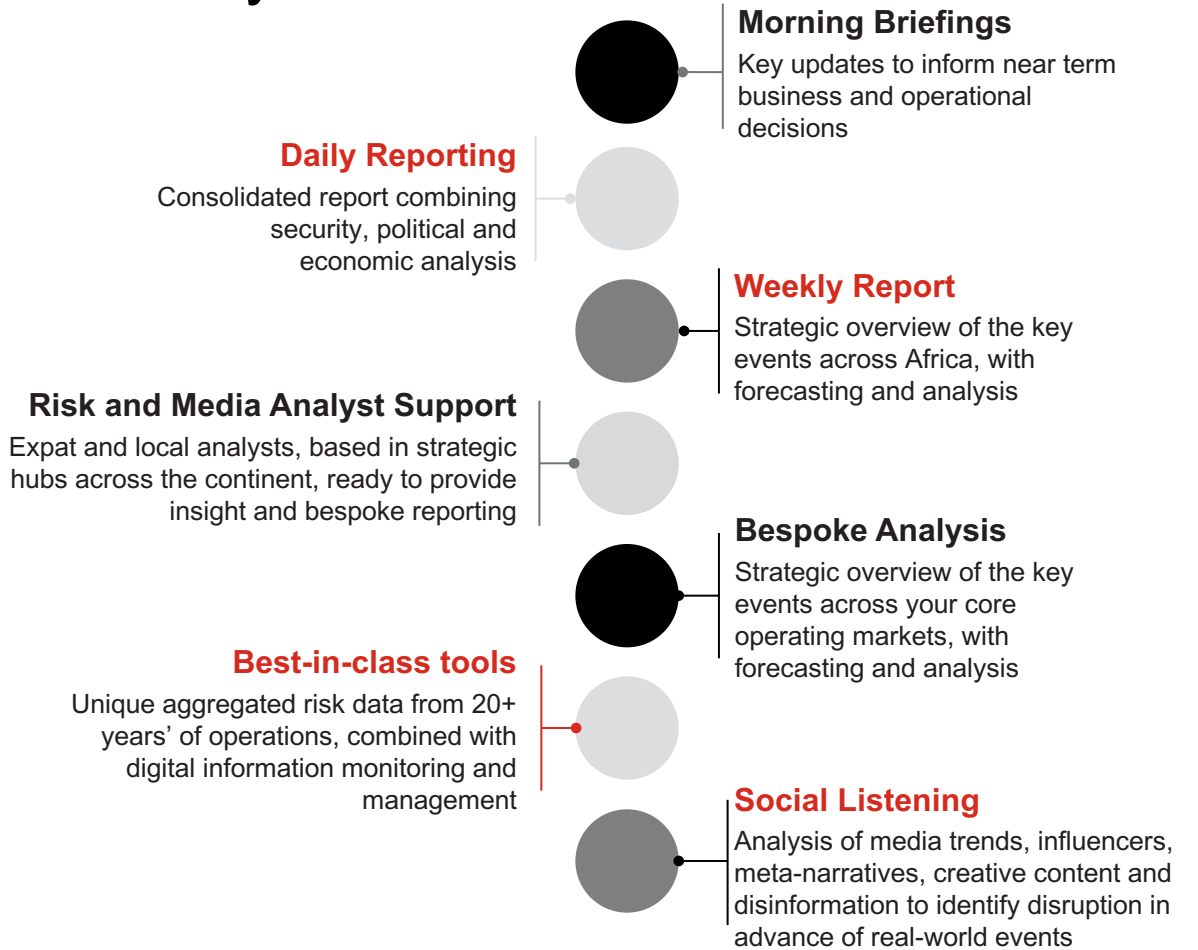

Government & Diplomatic: A Case Study

HMG Foreign Commonwealth & Development Office (FCDO) - Iraq

 - Wider operations support from within Iraq RMT, Dubai and London, and senior contract management in London to meet FCDO expectations)
